2.7 **Drivers' Briefing**

Time: 8:45am Location: Control Tower

IT IS COMPULSORY FOR ALL DRIVERS TO ATTEND THE DRIVERS BRIEFING. Scrutineering will cease whilst the Drivers' Briefing is in progress. A Driver sign-on sheet must be completed by all Drivers to prove Briefing attendance. **FAILURE TO ATTEND OR SIGN ON MAY RESULT IN PENALTIES BEING APPLIED BY THE STEWARDS OF THE MEETING.** The Organising Club must retain these sign-on sheets for any incident or accident reporting.

2.8 **Number of Laps.**

Each run will comprise a **minimum time to allow all competitors to complete at least 3 timed laps**, with the time for the fastest single lap being used for results. **The minimum time for each run will be six minutes.** The proposed **minimum number of runs on the day will be five.**

(Note: the Event will not be concluded when this minimum is achieved. Event will only be concluded early for safety Reasons or if no competitors available)

2.9 Entries

- a) Maximum number of Driver entries for the Event: 108. Reserves: 5
- b) Maximum number of Drivers per Competitor 2. Dual entry of drivers in Type 5 (refer clause 1.9) will be at the discretion of the Organising Club.
- c) Drivers must be a member of a CAMS Affiliated Car Club and must present their **CAMS Affiliated Car Club membership card**, **CAMS licence card** and **CAMS licence book** at registration.
- d) Vehicles must either be currently road registered and/or be issued with a CAMS Log Book
- e) Preferential Opening Date for Championship Registrants 25th February 2019.
- f) General Opening Date 11th March 2019
- g) Entry Fee \$210. Mini Car Club of NSW members, \$190.
- h) Timing Transponder hire if required \$ N/A.
- i) Entry Closing date: 14th April 2019.
- j) No late entries will be accepted.
- k) A pit usage fee of \$ N/A. Per garage will be levied by the circuit owners.
- l) Entries will be accepted in order of receipt and must be sent to the Event Secretary on a completed Entry Form, accompanied by the appropriate entry fee. Cheques or money orders are to be made payable to the Organising Club. Credit Card details are to be completed on the entry form.
- m) Entries from Drivers between 14 and 18 years of age must be counter-signed/consented by a Parent or Legal Guardian on the Official Entry Form.

2.10 Event Schedule

Start time 9.30am.

Finish time 4pm

2.11 Drivers Code of Conduct

Penalties for breaches of the Drivers Code of Conduct included in the Championship Sporting Regulations may apply.

2.12 Pre-Event Scrutineering at Circuit

All Competitors must attend. Start time 7.15am.

Finish time 9.30am.

Note: The Event will not be delayed due to late arrivals. It is the Drivers/Competitors responsibility to ensure their vehicles are scrutineered before the scheduled starting time of the Event. The driver must attend scrutineering personally.

2.13 Prizes / Awards

- a) Outright 1st, 2nd and 3rd
- b) Other awards at the Organisers discretion.
