NSW STATE CHAMPIONSHIP MOTORKHANA – Round 5

1. **This event** will be known as “**NSW State Motorkhana Round 5**” hereafter referred to as “**The Event**”.

Authority: The Event will be conducted under FIA International Sporting Code including Appendices and the National Competition Rules (NCR), the National Motorkhana Code (NMC), the NSW Motorkhana Addendum, these Supplementary Regulations and any Further Regulations which may be issued.

This Event will be conducted under and in accordance with CAMS OH&S and Risk Management Policies, which can be found on the CAMS website at www.cams.com.au

2. **CAMS Permit No** tba

The CAMS permit will be displayed at the start of the event.

3. **Type of Event:** State Championship Motorkhana

4. **Organising Club:** Mazda MX-5 Club of NSW Inc.

5. **Venue:** Nirimba Education Precinct, Eastern Rd, Quakers Hill

6. **Date:** Sunday 12th August 2018

7. **Type of surface:** Tarmac

8. **Tests:** Minimum of 6 tests as per motorkhana code.

10. **Event Schedule:** Start time: 10.00 am Finish time: 4:00 pm.

11. **Entry Fee:** Adults \$75, Juniors \$35

12. **Entries**

- a) Maximum number of entries for the Event: 60 Reserves: 5

- b) Opening Date: **Friday 6th July 2018**
- c) Closing Date: **9:30am Sunday 12th August 2018**
- d) A NSW Motorkhana Championship competitor is defined as an entrant in a previous state motorokahan round in 2018.
- e) Entries are open to all members of CAMS affiliated car clubs.
- f) Preferential opening date: **Friday 6th July 2018** for NSW Motorkhana Championship competitors.
- g) General opening date: **Monday 23rd July 2018** for all competitors.
- h) Should the maximum number of entries be exceeded then preference will be given to NSW Motorkhana Championship competitors up to Monday 23rd July 2018 and then in order of entry date received irrespective of championship status..
- i) Entries must be lodged on the event entry form with the event secretary via email or mail.
- j) Entries from people under 18 years of age must be counter-signed/consented by a parent or legal guardian.
- k) Maximum number of drivers per vehicle is four. (4).
- l) If an entrant advises the event secretary that he/she is unable to attend the event, the following procedure regarding a refund applies: **at the organiser discretion.**
- m) Entries may be refused in accordance with NCR 83 of the current CAMS Manual of Motor Sport.
- n) Competition numbers shall be allocated at the discretion of the Event Secretary in order of receipt.

13. Tests:

Minimum of 6 tests as per motorkhana code.

Drivers will be advised of the selected tests at registration.

14. Minimum licences:

CAMS current L2NS/L2NSJ or superior CAMS license with current membership of a CAMS affiliated club. Drivers must present their licence, current club membership and car log book (if issued) during registration.

15. Juniors:

Junior drivers (ie under 16 years of age as of the date of the event) will be required to carry a parent or guardian as a passenger until event officials are satisfied with their driving capabilities. That parent or guardian must be the person who signed giving consent for the junior on their CAMS disclaimer form.

16. Scrutineering:

- a) Start time: 8:00 am Finish time: 9.30 am
- b) Location: Scrutiny area near event admin shelter
- c) All apparel shall comply with Schedule D of the current CAMS Manual of Motor Sport
- d) A helmet is not mandatory except for drivers of Motorkhana Specials. Where a helmet is worn it must comply with Schedule D of the current CAMS Manual.
- e) All cars must comply with Schedule A and Group 4H of the current CAMS Manual.
- f) Cars must be adequately muffled to comply with noise restrictions.
- g) Fuel must be in accordance with Schedule G of the current CAMS Manual.
- h) Any camera or video recording device mounted in or on a competition vehicle must be approved by the Chief Scrutineer. Cameras mounted on specials or on the exterior of other vehicles must have a secondary restraint if the primary mount is by suction cup(s).

17. Classes:

Motorkhana Classes:

- Class A Production Vehicles Wheelbase up to 2150mm
- Class B Production Vehicles Wheelbase 2151 to 2390mm
- Class C Production Vehicles Wheelbase 2391 to 2574mm
- Class D Production Vehicles Wheelbase 2575mm and over.
- Class F Front Wheel Drive Specials
- Class G Rear Wheel Drive Specials

Class H Production Vehicle Based Specials

Non production 4WS (4 Wheel Steering) and 4wd vehicles are not permitted

Motorkhana Categories:

(Nomination in a category does not preclude a driver from competing for class awards)

Category J Juniors

Category LP Ladies in Production Vehicles

Category LS Ladies in Specials

18. Results, Prizes and Trophies:

1st Outright, 1st in each Class (minimum 3 entries in Class), 1st in each Category (minimum 3 entries in Category). Other awards at the Director's discretion. All awards are mutually exclusive.

Results shall be determined by the lowest aggregate of elapsed times on the tests completed, inclusive of penalties. Timing shall be to 0.01 second.

19. Drivers' Briefing is compulsory (**all** participants must attend and sign attendance sign-on sheet). Failure to attend or sign on may exclude the driver from the program.

Time: 9.45 am

Venue: Near the event admin shelter

20. Authority of officials:

Any competitor not following a reasonable instruction by an official during the Event may be excluded.

21. Insurance:

Personal Accident Insurance is provided by the purchase of a CAMS Level 2NS/2NSJ Licence or superior (2NS/2NSJ is the minimum requirement). Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at www.cams.com.au.

22. Start and Finish Procedures shall be in accordance with Article 13 of the National Motorkhana Code. Running order shall be at the discretion of the Clerk of Course.

23. Protests must be lodged in accordance with Part XII of the current CAMS Manual of Motor Sport.

24. Postponement / abandonment / cancellation. The organisers reserve the right to postpone, abandon or cancel the Event in accordance with NCR 59 of the current CAMS Manual of Motor Sport.

25. Alcohol, Drugs and Other Substances: Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

26. Refreshment facilities: None available at venue.

27. Toilet facilities are available near the TAFE library.

27. Fuel is not available at the venue. The closest service station is on the corner of Grady St and Quakers Hill Parkway, five minutes drive.

- 28. Additions and/or alterations.** Any additions and/or alterations to these Supplementary Regulations will be notified to all entrants in Further Regulations or during the Drivers' Briefing.
